- 1. The paper must be submitted as a Microsoft Word file attachment, and must be written in double-spaced Times Roman 10.5 point font.
- 2. The page format should be set for A4 size with left-hand justification only. Margin should be set 25mm each on all sides.
- 3. The body of the manuscript must be 5,000 words or less in length. Endnotes, bibliography, and other additional material are excluded from this word count.
- 4. Chapter, Section and Subsection Headings; follow the example below
 - 1. Chapter Headings
 - 1.1 Section Heading
 - 1.1.1 Sub Subsection Heading
- 5. Quotations and Citations

Block quotations, extracts or excerpts should be set off from the text, without quotation marks. They should be set in type that is one point smaller than the text.

Full citations of literature should be placed in the references section at the end of the chapter or manuscript. Within the text, only brief author-date citations should be made, giving the authors' surname, year of publication, and page number(s) where relevant. Such brief citations should be given in the body of the text, not in footnotes.
